3.6. You must retain your original paid invoice and/or receipt as proof of purchase. Purchaser will be required to present original proof of purchase when collecting their redemption.

4. Welcome Gifts

4.1. Gifts are given strictly on a first-come-first-served basis, and only while stocks last.

4.2. HP reserves the right to replace the gift with another of same value without prior notice.

4.3. No colour selection or exchange will be allowed.

5. How redemptions will be fulfilled?

5.1. The eligible recipients will be informed via text message, email or phone call by the HP Office Printing Club.

6. Claiming a Redemption

6.1. Gift recipients will be required to sign and return a Declaration and Release Form which, among other things, releases HP, the sponsor of the gift, its respective subsidiaries and associated companies, agents, including advertising and Membership agencies, from all liability relating to the Membership and acceptance and/or use of the gift and confirms his/her compliance with the terms and conditions applicable to the gift.

6.2. Gifts will be delivered to the recipients.

6.3. HP shall not be responsible for any additional charges incurred (including but not limited to charges for 3rd party collection, delivery, insurance, etc) to recipients who fail to receive the gift either by means of address error by the recipient, or where the recipient is physically absent during delivery or chooses to make special collection arrangements or pick-up services.

HP is not responsible for printing or typographical errors in any materials or for registrations, redemption forms or submissions that are illegible, incomplete, lost or misdirected, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly or are lost for any reason including electronic, computer, telephone, paper transfer, mail system, human or other error; including inability to access any website associated with the Membership. Proof of submission shall not constitute proof of receipt by HP.
- 7.2. If any information provided on a redemption form is found to be misleading or inaccurate, that entry shall be deemed invalid.

8. Goods as gifts. Where the gifts under the Membership are items/goods, they shall be subject to availability and may not be substituted for cash. HP reserves the right to offer an alternative gift of equivalent monetary value, without prior notice. No correspondence will be entertained.

14. No cheating tolerated. You acknowledge and agree that no form of cheating will be tolerated. If you are found cheating, as determined in the sole and absolute

discretion of HP, you will immediately be disqualified from the Membership. 17. All information is correct at the time of publishing. In the event of any inaccuracy or any discrepancy between the print and online versions, the online version shall prevail over the print version.

18. Severability. Each of the provisions of these Terms and Conditions apply to the maximum extent permitted by applicable law. If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the rest of these Terms and Conditions will remain in effect and these Terms and Conditions will be amended to give effect to the eliminated provision to the maximum extent possible.

19. Laws. The Membership shall be governed by and interpreted in accordance with the laws of Malaysia. The Membership is void where prohibited or restricted by law, and is subject to all applicable laws.
